- **Be tax-exempt under Section 501(c)(3) of the IRS Code**
 - **Be incorporated in the State of Texas.**

OUR PRIORITIES

We only support local nonprofits that serve **Taylor, Hutto, and Georgetown**—fueling bold ideas and helping community heroes do their best work in these areas:

- **Give underserved K-12 students more opportunities to thrive.**
Help students succeed by providing nourishment, guidance, and opportunities to grow into healthy, engaged members of the community.
- **Foster an entrepreneurial spirit among youth and young adults in underserved areas.**
Empower young people by teaching life and workplace skills such as personal responsibility, leadership, financial literacy, and problem-solving in our underserved communities.
- **Provide independence and dignity to seniors trying to live at home.**
Enable older adults to live safely and independently at home, with the dignity and support they need to remain vital members of their community.

2025 GRANT OPPORTUNITIES

This year, our funding continues to support **Organizational Sustainability Projects** for nonprofits.

Your grant requests need to consist of individual projects that fall in **one or both** of these categories:

- **Immediate, Unexpected Operational Need**
- **Long-Term Organizational Capacity Building**

Only salaries **for staff time spent on a funded grant project** are eligible. General salary support is not eligible.

1. Immediate, Unexpected Operational Need Projects

Covers urgent, unplanned, or previously deferred needs, such as:

- Sudden operational cost increases (e.g., rent, insurance, essential services)
- Critical building repairs (e.g., roof, HVAC)—excludes new construction, capital campaigns or planned building maintenance programs
- Upgrades to essential software (e.g., finance, training, cybersecurity)
- Other short-term operational priorities

2. Long-Term Organizational Capacity Building Projects

Supports planning projects, including consultant costs, to strengthen your nonprofit's long-term health and viability, such as:

- **Mission Development** – Strategic planning, program evaluation
- **Leadership Training** – Succession planning, staff/board development
- **Finance & Compliance** – Budgeting, IT, risk management, legal/admin systems
- **Resource Development** – Marketing and donor relationship planning (Note: event-specific fundraising is not eligible)

GRANT FUNDING THRESHOLDS

- Individual project grants: **\$1,500 – \$18,000**
- Multiple projects in one grant application: **up to \$20,000 total**

Please note: If you received funding in 2024, you are not eligible to apply again until 2026. Approved grants may be awarded at less than the requested amount.
